Hong Kong and the United Arab Emirates (UAE) make for ideal partners, not just in the pursuit of business and investment opportunities, but also in forging stronger cultural and social exchanges between Asia and the Middle East.

His Excellency Shaikh Saoud Ali M. A. Almualla, Consul General of the UAE in Hong Kong, highlighted the huge potential for closer bilateral ties, especially given the similarities between the two places.

"The similarities between major international financial centres and trade hubs such as the UAE and Hong Kong are striking, particularly when it comes to their economic dynamism, cultural diversity, and forward-looking ambition."

He noted that the UAE's foreign policy is firmly focused on long-term economic prosperity, with innovative strategies aimed at diversifying its economy and establishing a knowledge-based, technology-driven future.

"This drive for diversification and innovation mirrors the adaptability and ambition seen in Hong Kong, where forwardthinking approaches have allowed it to remain at the forefront of global trade and investment," Shaikh Saoud said.

The UAE is Hong Kong's largest trading partner in the MENA (Middle East and North Africa) region. The Hong Kong SAR Government also opened an Economic and Trade Office in Dubai in 2021, demonstrating



the city's long-standing commitment to developing bilateral relations with the UAE and beyond.

While Hong Kong is regarded as one of the easiest places to do business and is rated as the world's No.1 freest economy in the latest Economic Freedom of the World Report 2024 by Canada's Fraser Institute, the UAE is also enhancing its appeal for foreign investment.

"I would strongly encourage investors to consider both Hong Kong and the UAE as key destinations for business expansion," said Shaikh Saoud.

"Setting up a company in Hong Kong is a relatively simple and efficient process.

"At the same time, I would recommend that Hong Kong investors explore opportunities in the UAE. The UAE has firmly established itself as a leading international financial and trade hub, attracting substantial foreign investment. The recently launched "Invest in the Emirates" campaign highlights the UAE's rapidly

growing innovation ecosystem, which offers comprehensive support to businesses, including funding, favourable regulatory frameworks, and strong government backing."

Comparisons between Hong Kong and the UAE, including major cities such as Dubai and Abu Dhabi, go beyond the realms of trade, finance and investment, explains Shaikh Saoud.

"Culturally and socially, both the UAE and Hong Kong are melting pots of diverse communities, where multiculturalism is celebrated," he says.

"The UAE is home to more than 200 nationalities, living and working together in peace and harmony. Residents of both Hong Kong and the UAE benefit from a rich cultural tapestry, where the fusion of traditions and ideas leads to innovative solutions and a dynamic way of life."

Arriving in Hong Kong in 2021 to serve as Acting Consul General and then taking up his current post as Consul General a year later, Shaikh Saoud shared his experiences of the city's culture and lifestyle.
